Terms and conditions

- 1) Customer executing this agreement must be the titled owner of the boat in question.
- 2) Winter storage – Labor Day to Memorial Day. All boats stored prior to Labor Day or launched after Memorial Day will be charged the applicable daily dockage fee even while remaining on land.
- 3) I authorize the applicable work described on page 1 to be done along with the necessary materials, and hereby grant my permission to operate the boat and motors, as necessary, for the purpose of said work (including testing and/or inspection).
- 4) I agree that the City of Rogers City, owner and operator of Rogers City Marina, is not responsible for any loss or damage to said boat, motors, or contents resulting from, but not limited to, vandalism, theft, fire, wind, rain, snow, ice, part failure, collision, or act of God. I understand it is my responsibility to maintain a valid and adequate marine insurance policy including liability coverage on all units serviced and/or stored at Rogers City Marina.
- 5) Winterization of freshwater accessories is mandatory for all boats stored at Rogers City Marina.
- 6) The City of Rogers City cannot be held accountable for freezing damage caused to boat or motors made available for service/storage on or after October 15.
- 7) The City of Rogers City reserves the right to refuse the use of customer-supplied parts or supplies.
- 8) Due to insurance regulations, no independent contractors, service organizations, or outside individuals will be allowed to perform work at Rogers City Marina without first receiving permission from the City of Rogers City. Additionally, all contractors, organizations, or individuals selected to perform such work must provide the City with a certificate of insurance coverage which includes both liability and workers compensation and names the City as additional insured.
- 9) I understand that my boat will be stored in the unfenced Rogers City Marina parking lot, and that City of Rogers City does not provide security, supervision, or monitoring of the storage location.
- 10) I agree that the City of Rogers City shall have a lien on my boat and motors to secure the amount of service and/or storage charges and fees which shall remain in force and effect until payment in full of all charges. This lien gives the City of Rogers City the right to possession of my property until payment in full.
- 11) A service charge of 1.5% per month will be added to all balances not paid within 30 days of invoice date.
- 12) I agree to be personally responsible for all attorney fees incurred by the City of Rogers City to collect any outstanding balances due.
